Dear Cystinosis Community,

Leadiant Biosciences, Inc., is pleased to share an important update regarding **CYSTARAN® (cysteamine ophthalmic solution) 0.44%**. Beginning December 22, 2025, shipments of CYSTARAN received through Walgreens Specialty Pharmacy must be stored in the refrigerator upon delivery. Do **NOT** freeze the medication.

CYSTARAN bottles labeled “New Storage” and marked with Lot #: 300625 and an expiration date of 05/30/2026, and any subsequent bottles received after December 22, 2025, must now be stored in the refrigerator upon receipt. **Bottles with older expiration dates will continue to follow previous frozen storage requirements.**

This change provides a more stable environment for the product and for shipping.

CYSTARAN® Storage Instructions

When you receive your medication:

1. Check your Cystaran carton, foil, and bottle to locate the NDC number, Lot number and Expiration Date.
2. Medication labeled **“New Storage”** must be stored in the refrigerator upon delivery. **Any bottles with Lot # 100225, Expiration Date 1/31/2026 must continue to follow the frozen storage requirements.**
3. Please make sure you are following the correct storage instructions based on the medication received.

NEW Refrigerated Storage Instructions for CYSTARAN NDC# 54482-035-02

Before Opening CYSTARAN:

- Store unopened bottles in the refrigerator at **2°C to 8°C (36°F to 46°F)** in the original carton and the unopened foil wrapping.

Opening CYSTARAN:

- Open the carton and the foil wrapping only when starting a new bottle.
- Record the discard date on the bottle, which is one week from the day the foil wrapping and bottle were opened.

After Opening CYSTARAN:

- During the week of use, store the bottle at room temperature, **20°C to 25°C (68°F to 77°F)**.
- Discard the bottle one week after the foil wrapping and bottle were opened, even if there is medication left inside.

Frozen Storage Instructions for CYSTARAN NDC# 54482-020-02

Before Opening:

- Store unopened bottle in freezer at **-25°C to -15°C (-13°F to 5°F)** in the original packaging including unopened foil.
- Thaw for approximately 24 hours before use.

Opening:

- Open the carton and the foil only when starting a new bottle.
- Record discard date on the bottle, which is 1 week from the day the foil and bottle were opened.

After Opening:

- Store thawed bottle at **2°C to 25°C (36°F to 77°F)** for up to 1 week.
- The thawed bottle does not require refrigeration between use.
- Do not refreeze the thawed medication.
- Discard 1 week after the foil and bottle were opened even if there is medication left in the bottle.
